

## Limited Warranty- HID (High Intensity Discharge Lamp)

Plusrite Corporation warrants brand of Plusrite H.I.D (High Intensity Discharge Lamp) of Mercury Vapor, Metal Halide, and High Pressure Sodium lamps purchased will be free from defects in material and workmanship for the respective periods of time set as below. The warranty is limited to distributors with original invoice, under the brand of Plusrite.

### LAMP REMEDY

Plusrite Corporation's obligation under this warranty is expressly limited to lamps that fail to operate. If H.I.D. fails due to defects in materials or workmanship within (i) one (1) year after the original date of purchase from Fanlight, or (ii) within 5,000 hours of operation, whichever comes first, then Fanlight will replace the failed lamps.

1. This warranty applies only to lamps that are operated on a burning cycle of 10 hours or more per start; operated on suitable ballasts that have been properly wired and installed; operated within the electrical values shown on the ballast label; and operated in lighting equipment designed and approved for the application and in environmental conditions (temperature, humidity and air movement) within the normal specified operating range of the system.
2. Lamp must be operated on current ANSI compliant magnetic ballast or ANSI approved electronic ballast.
3. Fanlight Corporation reserves the right to examine all failed lamps to verify cause of failure and shall be the sole judge as to whether the lamps are defective.

### TERMS & CONDITIONS

The foregoing lamp warranty applies only to Plusrite H.I.D. lamps originally distributed by Authorized Plusrite Distributor, but does not apply to failures caused by acts of nature or as a result of any abuse, misuse, abnormal use, or use in violation of any applicable standard code, or instructions for use in installations, including, but not limited to, those contained in the National Electrical Code, the Standards for Safety of Underwriters Laboratory, Inc., Standards for the International Electrotechnical Commission, Standards for the American National Standards Institute or, in Canada, the Canadian Standards Association. Plusrite reserves the right to examine failed lamps to determine the cause of failure and patterns of usage. The date of purchase and lamp installation date must be verified to validate the elapsed operating hours if a warranty claim is made. If lamp life is not validated, the lamp date code will be used to establish elapsed burning time based on estimated usage.

**The foregoing warranty constitutes the sole and exclusive remedy of the purchaser and sole liability of Plusrite for warranted lamps. NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR PARTICULAR PURPOSE IS MADE OR IS TO BE IMPLIED. In no event shall Plusrite be liable for any other costs or damages including lost profits, incidental, special or consequential damages.**

### TO MAKE A WARRANTY CLAIM

Retain the failed product and notify your Authorized Plusrite Distributor within thirty (30) days of the failure. This warranty extends only to Plusrite H.I.D. lamps purchased and distributed by authorized distributors.
