SECTION 2. COMPOSITION / INFORMATION ON INGREDIENTS

Ingredients: FloraShield™ is a mixture of chemicals specifically formulated for use in hydroponics cultivation. The chemical identity of the compounds and exact proportions used in the mixture are a trade secret.

Exposure Limits: No limits are established for exposure to FloraShield TM.

SECTION 3. HAZARDS IDENTIFICATION
