
### Installation Instructions


- 1. Turn off the power to the luminaire. (Fig. 1)
- 2. Remove diffuser (if provided).
- Remove the existing fluorescent lamps from the luminaire. Verify the fluorescent tube type is listed on the label of MaxLite LED T5 DirectFit lamp. (Fig. 2)
- **4.** Dispose the existing fluorescent lamps in accordance with government regulations in your area.
- 5. Install MaxLite LED T5 DirectFit lamps. Ensure that the pins are firmly seated in the lampholders. (Fig. 3)
- 6. Replace diffuser (if removed in step 2).
- 7. Switch on power to the luminaire. (Fig. 4)





