- All wiring connections should be capped with UL approved wire connectors.


RISK OF FIRE



#### **General Wiring Diagram**

CAUTION: Turn off electrical power at fuse or circuit breaker box before wiring fixture to the power supply.

All units must be individually connected to the AC supply. (see page 1 for voltage by model)



## **AC** wiring instructions

- 1. Feed wires through way and secure using connector (not supplied) if needed.
- 2. Connect supply wires to quick connect originating from INPUT side of driver. Black/Hot supply to quick connect with black wire. White/Neutral supply to quick connect with white wire. Be sure to confirm connections are secure.
- 3. Connect ground wire to quick connect with green wire. Be sure to confirm grounding connection is secure.





## **Installation & Operation**

## **Arm Mounting Instructions:**


For convenience, it is recommended that the mount be configured prior to installation on the tenon.


- 1. The Flood Light Arm, tenon slip fitter, can be field mounted to aim directly at its object.
- 2. Place both threaded rods through the two holes shown below in Figure 1.
- 3. Then place the gasket on one end of the arm, see Figure 2.






- 4. Then place assembly next to the fixture housing and place rods through the aligned holes. Be sure the tenon arm is the right-side up and aligned creating a flat plane along the fixture surface. (See **Figure 3**)
- 5. Place the other gasket plate on the other end of the housing.
- Place the metal plate on the interior of the housing ensuring the holes are aligned.
- 7. Place the power leads first through the square arm then into the fixture housing as shown above.
- 8. Place the flat washer, split lock washer, and the nut on each end of each threaded bolt.
- 9. The entire installation order should follow Figure 4.
- 10. Fasten the assembly by tightening each pair of nuts with two adjustable wrenches.
- 11. The fixture door is then fastened to the fixture housing ensuring a tight seal.
- 12. (Caution: Do not over tighten, creating small rips in the gasket)
- 13. Supply power to the fixture and enjoy your new LED Area Light.

#### Warranty

LIMITED WARRANTY FOR CERTAIN MAXLITE® LED LIGHTING FIXTURES, SPECIFICALLY WALL PACKS; FLOOD LIGHT; AREA LIGHT; CANOPY; GARAGE; PARKING; SECURTIY LIGHT; VAPOR TIGHT AND ROADWAY.

This limited warranty is provided by the MaxLite company described below ("Seller") to you as the original purchaser of the LED lighting product that is identified on Seller's invoice reflecting its original purchase (the "Product"). The Seller is the MaxLite Company identified as such on the invoice. This limited warranty may be transferred to subsequent purchasers of the Product, provided that such Product is resold in new condition and in its original packaging. Seller warrants that the Product, when delivered in new condition and in its original packaging, will be free of defects in material and workmanship for a period of FIVE (5) YEARS from the date of original purchase or the number of hours used has not exceeded the L70 life stated for each LED fixture. The determination of whether the Product is defective shall be made by Seller in its sole discretion with consideration given to the overall performance of the Product. A Product shall not be considered defective solely as a result of the failure of individual LED components to emit light if the number of inoperable components is less than 10% of the total number of LED components in the Product.

If Seller determines the Product is defective, Seller will elect, in its sole discretion, to refund you the purchase price of the Product, repair the Product or replace the Product. This limited warranty does not apply to loss or damage to the Product caused by: negligence; abuse; misuse; mishandling; improper installation, storage or maintenance; damage due to fire or acts of God; vandalism; civil disturbances; power surges; improper power supply; electrical current fluctuations; corrosive environment installations; induced vibration; harmonic oscillation or resonance associated with movement of air currents around the Product; alteration; accident; failure to follow installation, operating, maintenance or environmental instructions prescribed by Seller or applicable electrical codes; or improper service of the Product performed by someone other than Seller or its authorized service provider. This limited warranty excludes field labor and service charges related to the repair or replacement of the Product. THIS LIMITED WARRANTY IS VOID IF THE PRODUCT IS NOT USED FOR THE PURPOSE FOR WHICH IT IS DESIGNED.

Seller reserves the right to utilize new, reconditioned, refurbished, repaired or remanufactured products or parts in the warranty repair or replacement process. Such products and parts will be comparable in function and performance to an original product or part, as determined by Seller in its sole discretion, and warranted for the remainder of the original warranty period.

In order to make a warranty claim, you must notify Seller in writing within sixty (60) days after your discovery of the defect, provide proof of purchase such as the invoice and comply with Seller's other warranty requirements. Upon receiving that notice, Seller may require you to promptly return the Product to Seller, or its authorized service provider, freight prepaid.
