Bulbrite offers a 1, 3 or a 5 year limited warranty on LED products (based on an average household use of 3 hours per day), depending on the product. This warranty is only applicable when a Product is properly installed and used in agreement with Bulbrite's product specifications and operating guidelines. Use of the Product in lighting equipment designed and approved for the specified application and in environmental conditions (temperature, humidity) within the specified operating range are required. This warranty will become void if the Product is altered, modified or used in violation of applicable standard, code or instructions for use in installations in the U.S. and Canada, including the following: National Electrical Code (NEC), Standards for Safety of Underwriters Laboratory, Inc. (UL), Standards for the American National Standards Institute (ANSI), Canadian Standards Association (CSA). This warranty will not apply in the event of conditions demonstrating abnormal use or stress, including under/over voltage/current conditions, excessive switching cycles or operating hours, or conditions outside the following recommended operating conditions:

- Ambient operating temperature: -20C to +40C
- Operate at rated AC Voltage
- Dimming applicable to instructions on packaging or Product markings.

Bulbrite reserves the right to examine all failed lamps and/or ballast and reserves the right to be the sole judge as to whether any lamps and/or Bulbrite lighting products are defective and covered under this warranty. This product will be credited, repaired or replaced at Bulbrite's option and associated labor costs will not be covered.
