This limited warranty only applies when the product has been properly handled, stored, transported, wired, installed and operated within the electrical values, operating range and environmental conditions. Our warranty covers only the product iteself, naturaLED<sup>®</sup> will not cover the liability for labor costs, installation costs, or other losses. This warranty does not apply to damage or failure to perform arising as a result of any acts of God, or from any abuse, misuse, abnormal use, power surges or spikes, corrosive environments, neglect, or any use/installation in violation of the instructions or restrictions prescribed applicable standard/code.

The limited warranty shall be void in the event any repairs or alterations are made not authorized by Plusrite<sup>®</sup>USA. The warranty is void if the product is not used for the purpose for which the product is designed.
