This is if the product has not been damaged through misuse, abuse, accident, modifications, alterations, neglect or mishandling. This warranty shall not apply to any product that is found to have been improperly installed, set up, or used in any way that is not in accordance with the instructions supplied with the product.

#### SATCO's NUVO 3-Year Limited Warranty

The decorative finish of all ENERGY STAR fixtures is warrantied for a period of (1) year. If this product is found to be defective, Satco's only obligation, and your exclusive solution, is the repair or replacement of the product at Satco's discretion.
